**VALORA TECHNOLOGIES ANNOUNCES UNITED STATES DEPARTMENT OF JUSTICE
COMMITMENT FOR THIRD YEAR IN A ROW**

US DOJ Renews Contract with Leading Document Encoding Solutions Provider

WALTHAM, MA – January 30, 2006 -- Valora Technologies, Inc., the leading state-of-the-art automated document encoding and unitization service provider for litigation support, announces that the United States Department of Justice has renewed its contract for automated document encoding and related services for another year. This announcement marks the third consecutive year of service by Valora for the largest litigation entity in the U.S., and one of the largest teams in the world.

Under the original (and renewed) contract, Valora is obligated to turn around all projects received from the DOJ within two weeks and with 98.5% accuracy or higher. “The terms of the contract illustrate the Department of Justice’s high level of confidence and commitment to Valora’s capabilities. It also demonstrates Valora’s unique and nearly unlimited capacity to handle document encoding projects on a tight turnaround,” said Sandra Serkes, President and CEO of Valora Technologies. “It’s an impressive thing to be able to do with no notice and for any size volume.”

Under its original contract, Valora is responsible for over 17 million pages for the DOJ under a special umbrella contract covering over 50 unique matters. “As a result of our DOJ work to date, Valora has also been retained by other government clients, including other divisions of the Justice Department, the California and Massachusetts Attorney General’s Offices and the Office of Federal Housing and Enterprise Oversight (OFHEO),” said Valora’s Chief Technology Officer, Aaron Goodisman.

“Many of Valora’s clients, including the Department of Justice itself, require Valora’s staff and facility to have security clearance. Today nearly all Valora employees hold that clearance and our facility is approved for government-sensitive productions.”

All Valora Technologies’ work is guaranteed at 98.5% accuracy or higher under this contract. Furthermore, Valora’s work is reviewed for accuracy and completeness by an outside third party, Andrulis/Dynamics Resource Corporation of Andover, MA. Valora Technologies routinely scores over 99% on both Key Fields and Other Fields.

Valora's services are used to automate a wide range of manual processes, saving significant time and money, and increasing quality. The company's proprietary system automatically processes documents at record speeds (up to ten thousand documents per hour on each of 100 separate processors) and auto-populates document databases with full bibliographic and in-content data. All documents then go through a three-stage manual quality control check, ensuring near-perfect accuracy and consistency. The patent-pending Valora system is at the heart of its auto-encoding service and serves as the platform for other service offerings including automated logical document determination and electronic document encoding of native files.
